# **Luke Receives APPA Award**

Burlington's Mayor Stan Luke was recently recognized and awarded by the American Public Power Association (APPA) at their 2022 National Conference in Nashville, Tennessee. Mayor Luke received the Spence Vanderlinden Public Official Award which recognizes elected or appointed local officials who have contributed greatly to the benefit of public power and APPA.

Mayor Luke has served more than 15 years as an elected official, including eight years on the City Council of Burlington before being elected twice as the city's mayor. He has been instrumental for the Kansas Power Pool, having served on KPP's board of directors and as President. Mayor Luke has provided critical testimony on behalf of public power to both Congress and the Kansas State Legislature. He is currently chair of APPA's Policy Makers Council and, since joining the council, has regularly attended APPA's Legislative Rally, National Conference, and the Policy Makers Council summer fly-in.

# Johnson Receives APPA Public Power Manager Certification

Tim Johnson, Director of Public Utilities for the City of Augusta received the American Public Power Association (APPA) Academy's Public Power Manager Certificate.

The certificate was presented at the 2022 APPA National Conference in Nashville, Tennessee. To earn the certificate, recipients had to complete required courses and develop a plan that identifies and addresses an opportunity for improvement within their organization. To earn his certification, Tim examined new approaches to improve performance and prepare employees for future leadership roles. Tim is a current member of the KPP Board of Directors, a position he has held since 2020.

BROOKE CARROLL, DIRECTOR OF ADMINISTRATIVE SERVICES

Annually, KPP plans and budgets to support members with the implementation of electric vehicle charging infrastructure. KPP offers two programs to assist with educating KPP members and retail customers about EVs the KPP Level 2 Charger Program and KPP Electric Vehicle Charger Installation Rebate.

## The KPP Level 2 Charger Program

Each year KPP offers to the membership, on a first come, first serve basis, the option to participate in the KPP Level 2 Charger Program.

## **KPP's Obligations**

- Supplies the Charging Equipment for 1 or 2 Chargers
- Wraps the Charger with the City Logo
- Covers the Cost of an Electrician if Needed
- Arranges Promotion/Chamber Events
- Coordinates PlugShare Mapping

#### City's Obligations

- Obtains City Council Approval
- Determines Location(s)
- Prepares Location(s)
- Provides Any Desired Signage
- Provides Any Desired Metering

#### **KPP Electric Vehicle Charger Installation Rebate**

KPP provides rebates up to \$1,500 to member's retail customers for the installation of charging infrastructure in member's communities for residential or commercial use. The retail customer provides a completed application along with supporting receipts to city staff and then KPP reimburses the city for the rebate amount.

Recently, at the June 20th Augusta city council meeting, Brooke Carroll presented the details of the KPP Level 2 Charger Program to the governing body. The Council voted unanimously to participate and to move forward

with the installation of two chargers. The locations under consideration for the chargers include the downtown shopping and dining area and an area park. Other KPP members who have participated in the program include Ellinwood, Hillsboro, Kingman, Marion, Waterville, and Winfield

In the May 26<sup>th</sup> edition of The Marysville Advocate, the City of Waterville was recognized with the headline "Waterville Gets Electric Vehicle Charging Station – First in the County." The PlugShare mapping tool shows that the charger in Waterville is already getting use and assisting drivers traveling the county for work.

In February, the City of Hillsboro took the KPP rebate program even farther. The City adopted a policy to assist area car dealerships with a matching contribution of up to \$1,500 for charging infrastructure expenses in addition to a reduced rate on the electricity consumed, with a condition that the chargers must be open for the public to use.

# Hansen Passes APPA Chair's Gavel

On June 15<sup>th</sup>, KPP CEO & General Manager Colin Hansen completed his one-year term as the Chairman of the Board for the American Public Power Association (APPA). On the final morning of the APPA 2022 National Conference, Hansen passed the gavel to Tony Cannon, General Manager/CEO of the Greenville Utilities Commission in Greenville, North Carolina. Hansen will continue to serve as Immediate Past Chair for one year, which includes a position on the APPA Executive Committee and APPA Board of Directors. He will also chair the APPA Nominating Committee this year.

There were a number of association accomplishments during Hansen's year as Board Chair. Last November, the APPA Board adopted for the first time a five-year business plan that incorporates both the strategic plan and the financial plan for the association. Under that business plan, APPA currently does not plan to increase membership dues for the next five years.

In his outgoing Chair's comments, Hansen thanked the Board, membership and staff of the Kansas Power Pool. "I am incredibly grateful to the Kansas Power Pool Board of Directors and KPP membership for taking a chance on me as their next leader and supporting me over the past five

months as I shifted careers in the midst of a very busy year as your Board Chair," Hansen said. "Special thanks goes to my fellow staff members at KPP who are patiently training and educating me - and have covered for me – since I joined the agency in February."

"Thank you also to the Kansas Municipal Utilities Board, Executive Committee, and membership for their longtime support and guidance. It was an honor to directly serve the KMU membership for 22 years. Special thanks to my fellow KMU staff that supported me while I took on increasing responsibilities with APPA."

# **Evergy to Recover \$122.2 Million from Expenses Related** to Winter Storm Uri

The Kansas Corporation Commission (KCC) will allow Evergy to recover \$122.2 million from expenses incurred during February 2021's Winter Storm Uri. The average customer will see an increase of nearly \$3 per month in their utility bills. The increase will begin in April 2023 and last for two years. Evergy Kansas Central covers over 700,000 customers outside of the Kansas City Metro area, including Hutchinson, Topeka, Wichita, and much of eastern Kansas.


Evergy customers in the Kansas City Metro area (formerly Kansas City Power & Light) will actually see a credit on their bills due to the sale of excess power back to the Southwest Power Pool (SPP) during that same time. This credit results in a \$6.60 monthly reduction in utility bills for these customers.

A group of high-volume energy users opposed the settlement, claiming it unjustly shifted costs from residential customers to industrial customers and failed to reward conservation efforts. The Commission set aside those claims, ruling that with each customer class, some customers made efforts to conserve, while others did not.

The Commission also stated that any proceeds received by Evergy from ongoing federal or state investigations into market manipulation, price gouging, or civil suits will be passed on to customers subject to winter storm recovery charges.

**SURCHARGE RECOVERED: \$11,119,629** 






# **KPP Resources by Fuel Source**
